The League will also be distributing its English version of the Voters' Guide for the 2023 local elections with reliable voting information and candidate answers to questions from the League.

Topics to be discussed include changes in the state's voting laws under the state's 2023 Voting Rights Protection Act, how does rank-choice voting work in the City of Las Cruces elections for Mayor and City Council, how to support the integrity of our democratic elections by volunteering to serve as a poll worker or poll watcher and poll worker security.


Let's Push Election Turnout

Early voting for the local Nov. 7 General Election begins on October 10, 2023. The League has a number of ways that can help inform voters. First and foremost are the locally published Voters' Guides, in English and Spanish. Look for the English version in the *Las Cruces Bulletin*. The printed guide will cover races for the City of Las Cruces and the Town of Mesilla. It will be inserted in the Bulletin on Friday, October 13.

The Camino Real Media Voters' Guide will be printed in Spanish. On October 9, this guide will be inserted and delivered to various locations throughout the county and will feature the races outside of Las Cruces but within Doña Ana County, including Hatch, Sunland Park, Anthony, and the rural Water/Soil Conservation Districts.

Go to www.Vote411.org which will be available online shortly before Early Voting starts on October 10. All participating candidates' information should be available (in English) and the Vote411 website also contains a great deal of voter information such as how to register to vote, how to vote absentee, and much more.

Finally, in conjunction with KRWG Public Media, the League will be co-hosting a series of televised Candidate Forums featuring races for the Las Cruces City Council and Mayor, and the Las Cruces School Board. Our Newest Citizens Get Registered to Vote!

There were more than 130 citizens who took their Oaths of Allegiance as they became United States citizens at a September naturalization ceremony conducted by the US District Courts in Las Cruces. And in keeping with tradition, the LWVSNM was in attendance to help celebrate their new status and to register them to vote. Pictured to the right are voter registrars including LWV members (4th from right) Rebecca Courtney, and Stew and Karena Oberman. Past President Eileen VanWie and Co-President Jo Nash were introduced during the ceremony.

US District Judge Ken Gonzales (below) gave the keynote address and administered the oath. Ages of the immigrants ranged from 18 to 81. They were from many counties including Mexico, with the largest number, Japan, Canada, Columbia, Philippines, Australia, and Iran. Special recognition was bestowed to military personnel who are from several different countries and now serve with the US Army.

The guest speaker at the Sept. 16 meeting of the NAACP of Doña Ana County was Eric Enriquez, one of the candidates for Mayor. Meanwhile, the reports from the President and other officers included:

- There will be a November memorial service in Las Cruces for Delano Lewis, former U.S. Ambassador to South Africa, who died in Las Cruces in August.
- LC Police Chief Story will be the guest speaker at the chapter meeting in October.
- The State NAACP conference will be Nov. 10-11 in Albuquerque. Chapter delegates will be Bobbie Green (President), Terry Tolbert (Treasurer), Howard Guion (Secretary), Jennifer Kreie (At-large Executive Committee Member) and Secretary Liz Rodriguez-Johnson.
- Liz and Jennifer Kreie will be co-hosts for three of the candidate forums hosted by KRWG and the League of Women Voters.
- Liz is working with Stephen Jones on a campaign to get out the vote in rural Doña Ana County.
- People can now request their absentee ballot and it will be mailed early in October.
- The Library Advisory Board's Diversity and Inclusion subcommittee's report was endorsed. It is now part of the City's policies and procedures for its libraries.

In other business Reverend Carolyn Wilkins said there will be a candidate forum hosted by NM CAFé on October 3rd.

LAS CRUCES CITY COUNCIL • Work Session

August 28, 2023

The topic of the meeting was policing and the report of the OIR group on its most recent audit. Those with a strong interest in policing may want to review the recording and the audit report which can be found by accessing the agenda for the meeting: https://lascruces.civicweb.net/Portal/MeetingInformation.aspx?Org=Cal&Id=539

The police department is beginning the process of attaining accreditation through the Commission on Accreditation for Law Enforcement Agencies (CALEA). In the state, only the State Police and Hobbs have this accreditation. The department's use of force review process was also described.

OIR has a positive sense concerning the department's responsiveness under Chief Dominguez and Chief Story. During the most recent quarter eight formal citizen complaints and two internal investigations were reviewed. Two cases involved use of force allegations and one involved an allegation of racial bias (the first such case for OIR in Las Cruces).

LAS CRUCES CITY COUNCIL • Regular Meeting

September 5, 2023 Observer: Kathy Brook

Agenda items included approval of a contract for janitorial supplies and budget adjustments and Capital Improvement Plan amendments. In addition, there was a hearing involving appeal of a Planning and Zoning decision to deny a zoning change that would allow construction of a 20-unit apartment complex on McClure Road in an area of single family housing. The zoning discussion was interesting in that there was a balancing of the need for more affordable/attainable housing and for infill with the specific traffic issues of McClure Road. The motion failed so the zoning change was not approved.

LAS CRUCES CITY COUNCIL • Work Session

Two topics were covered: opioid settlement funds and cannabis revenue. Barbara Bencomo from the city manager's office, coordinated a presentation concerning the opioid settlement funds coming to the city and the county. The case, involving producers, distributors and retail establishments, was described as the biggest and most complicated case in US history. New Mexico is slated to receive about \$1 billion with funds going to the state, the City of Las Cruces, Doña Ana County, Sunland Park, and other localities within the state. In total, the county, Las Cruces, and Sunland Park will receive \$25 million spread over about 18 years. The agreement specifies that the funds will be used only for opioid remediation, including treatment and prevention strategies.



The City is currently working with the County on the use of the funds, including deciding how the funds will be handled over time. An advisory council of 10-15 people is being created to assist with the process. The state's approach is to invest the funds as they are received and to pay out annually 5% of the market value of the fund.

Ikani Taumoepeau, assistant city manager, coordinated the presentation on cannabis revenue. The city received about \$847,000 in cannabis revenue during the past fiscal year. The excise tax revenue currently flows into the city's general fund. A question under discussion is whether those revenues should be set aside for particular purposes or treated in the same way as most other sources of revenue.

LAS CRUCES CITY COUNCIL • Regular Meeting

September 18, 2023 Observer: Kathy Brook

Public participation: most of the public input involved complaints about crime, but concerns were also expressed about publicly funded guaranteed basic income and about the challenges of low-income people getting health care at a city/county leased hospital.

At the end of the meeting, the city manager noted that there is a security patrol in the downtown area at night and at least one councilor referred to efforts to examine ways in which the municipal code might be used to address crime. Councilors Corran, Gandara, and Bencomo spoke in support of the guaranteed basic income. (The Council awarded ARPA funds to the Community Action Agency to provide \$500/month for 18 months to 150 families selected to participate in the program.)

The Council approved acquisition of about one acre of land adjacent to the Mesilla Valley Community of Hope and approved use of Community Development Block Grant funds for a campus solar power project for Casa de Peregrinos.

LAS CRUCES BOARD OF EDUCATION • Regular Meeting

September 19, 2023, 6 pm Observer: Eileen VanWie

Members Present: President Teresa Tenorio, VP Pam Cort, Secretary Robert Wofford, and Members Carol Cooper and Patrick Nolan

There were 25 people signed up for public comment. Because of the large number of comments, they were limited to two minutes each. Themes included school resource officers, not banning books, civic education, mental health, and SPED teachers feeling belittled by administrators.

Superintendent Ignacio Ruíz is continuing his goal to visit all the Las Cruces schools. There was lengthy discussion about transportation issues again. STS Transportation, the district's bus contractor, is working to acquire enough drivers. Parents are frustrated. Salaries are low compared to other bus services in the state (\$15.94-18.80/hour compared to other companies that provide \$20-21/hour).

The Board discussed the School Resource Officers Agreement extensively. Robert Wofford thanked the students who spoke and the officers in attendance. He talked about the data he had read from the U.S. Department of Justice and others with evidence that with SROs in schools there is more crime reporting, especially with black and brown students, possibly contributing to the "school-to-prison pipeline." Consensus of available evidence does not support the belief that police presence makes schools safer overall. He observed from the many voices who spoke during public comment that there is a perception of school safety with SROs. "But does it really make schools safer? Maybe Las Cruces is different, but I don't know that."

Carol Cooper commented that students become more comfortable around police officers and benefit from SROs. Students had commented about having good relationships with their SRO. Pam Cort noted that she has observed in some schools the SRO sitting in his office not building relationships and sometimes making disparaging comments about students. Patrick Nolan talked about this being an accountability issue, which is expected of every employee.

Teresa Tenorio thanked the students who spoke, giving them practice with civic participation. She wants to look at the data with an equity lens and wonders why low-income students are facing issues. She sees a need to build support for social workers and counselors. Schools are using restorative justice practices. The Board approved agreements with LCPD and Town of Mesilla for the same number of SROs for the next school year on a 4 to 1 vote.
