Campaign to Establish Another National Monument

What do the New Mexican Floridas, Good Sight, Cookes Range and Tres Hermanas Mountains share in common? Together they comprise almost one-quarter of a million acres of public Sky Islands and Basins located in the Northern Chihuahuan Desert of our neighboring Luna County.

This important topic will be discussed at our General Membership meeting on Saturday, August 10th at 2:00 PM at the DACC Workforce Training Center located at 2345 Nevada Avenue, in Las Cruces. Snacks will be provided. Please bring a beverage.

Combined they form the heart of a proposed new national monument in Southern New Mexico. Authorized under the 1906 Antiquities Act, U.S. Presidents can proclaim federal public lands, waters, and cultural and historical sites as national monuments. Over 150 national monuments have been established or expanded since the Antiquities Act was signed into law by President Teddy Roosevelt including two in Doña Ana County. President Obama designated the Prehistoric Trackways in 2009 and the Organ Mountains-Desert Peaks in 2014 as national monuments because of their unique and nationally important cultural, historic, ecological, and/or scientific resources, objects and values.

Come learn more about the campaign (and opposition) to designate the Mimbres Peaks as a new National Monument from experts and residents who support designation: Ariana Saludares, BJ Trejo and New Mexico Wild's Wilderness Wrangler, Nathan Small, who has been on staff with New Mexico Wild since working to secure and then safeguard National Monument protection for the Organ Mountains-Desert Peaks.

THE LWV CONVENTION

The LWVSNM was represented at the LWV biennial national convention in Washington, D.C. during July. Secretary (and Director of LWVNM Voter Services) Edwina Jaramillo attended in person while President Jo Galván Nash and Past-President (and Co-President of LWVNM) Kathy Brook attended virtually. The four-day event was filled with topics that relate to Leagues across the nation such as getting-out-the-vote, abolishing the Electoral College, mis/disinformation to voters, corporate partnerships/fundraising, engaging young voters, redistricting, and voting rights. Hundreds of members from coast-to-coast were in attendance.

For those of us who attended, we are more than willing to share some of the salient ideas and embed them in our meetings, conversations, and activities.

Unfortunately, there was no session addressing the many questions about how dues will be processed by LWV beginning in 2025. One of the questionable areas is the national league's decision to eliminate the zero-dues level for students. One of the upcoming changes will allow for members who cannot afford the dues to "pay-what-you-can;" however, the minimum amount must be \$20.

In LWVSNM, students 16 years and older don't have to pay anything. Therefore, if the national process doesn't have a zero-amount category, will that mean local Leagues have to pay for students to continue their memberships? Or, will students simply be faced with a \$20 minimum amount? More news on that is to come.

League of Women Voters of SNM celebrated a red, white, and blue, traditional, small town, 4th of July in Silver City with an information table promoting Vote411, as well as League membership. Voters were attracted to the uniquely decorated table. An added feature was a special "Chile Pepper Poll" allowing those visiting the League's table to cast their votes for what they thought were the most important issues in November's General Election. The visitors used chile pepper stickers on topics that ranged from voting rights and climate change to immigration and crime prevention. Tax Increase Question Added to Nov. 5 Election Ballot

Voters who live within the Las Cruces city limits will decide whether to increase their gross receipts taxes when they vote in the General Election. The City Council approved the ballot question which will increase taxes by 0.3250% each year, generating approximately \$11 million per year.

If the tax question is approved, the City Council will then consider a separate ordinance which would impose another 0.2375%, bringing in \$9 million a year. The second option does not need voter approval. If both items are approved, the total would be a 0.5625% increase to gross receipts taxes, for a total of \$20 million annually.

With approval, the City estimates that median household incomes would pay an extra \$69 per year. The new tax would not impact groceries and medicine and would be effective on July 1, 2025, if approved. Capital outlay projects being considered with the tax proceeds have been a bone of contention. City officials said the monies would pay for items including enhanced public safety facilities, a west-side recreation center, park improvements and street repairs. However, it's been suggested that the funds be earmarked specifically for public safety; others feel the tax should have a sunset clause; some believe that the tax is too wide in scope and the public will not know how the money is being spent.

Concerns also were raised at a recent City Council meeting regarding confusion about having two separate ways to increase taxes and whether the election's passage will mandate that the second step — the city ordinance — be enacted. The ordinance is not a done-deal, and the Council will have to take a public vote by December on whether to impose it. City officials said that all public information about the election will be clear. For the ballot question wording, see above.

ALSO ON THE BALLOT:

There are three District Court Judges from Doña Ana County who will appear on the November ballot. They were not required to be on the ballot during the Primary Election, but in order to maintain their seats, voters must decide whether to retain them through "judicial retention." LWVSNM has asked them questions and we hope they will answer them in the Vote411 online guide and in our printed guides. The candidates are: Conrad F. Perea, Div. 3; James T. Martin, Div. 6; and Richard M. Jacquez, Div. 9. They do not run as Democrats or Republicans. Also appearing on the ballot will be a write-in candidate for County Commission in District 5, Marcy Renee Teague (Rep.), who will face Manuel Sanchez (Dem.).

Don't forget that dues (and any additional donation) are tax-deductible. Dues remain the same at \$65 for an individual; \$32.50 for a second same-household member; and \$0 for enrolled high school and higher education students, 16 years and older. As a reminder, the "round-up" is a new campaign to support our activities in this important election year. When paying your dues, consider adding a donation. For example, when you pay your \$65 dues, you can "roundup" with a \$35 donation, for a total of \$100. We're happy to report that many of you already have elected to "round up" your dues.

As a side note, if you joined the League last winter or spring, and if you paid \$32.50 for half the year, you would now want to consider paying \$65 to cover a full year's membership (May 2024 through April 2025).

Just in case you didn't know, the treasurer has a *big* bill to pay before election day — our two Voter Guides. This year, we estimate the two printed guides will cost approximately \$8,000. Your dues help to pay the bulk of that important project.



Las Cruces Public Schools Board of Education • Regular Meeting

June 18, 2024, 6:00 pm Observer: Eileen VanWie

Members Present: President Teresa Tenorio, VP Pam Cort, Secretary Robert Wofford, Ed Frank, and Patrick Nolan

There were 6 public comments made. Several related to support for bus drivers becoming direct employees of the LCPS. One comment reported that the district had made some positive responses to concerns by parents about library books that are not age appropriate. Jane Asche shared comments from the LWVSNM supporting the changes the Board is making to *Policy AD School District Vision, Mission, and Value Statement*.

Superintendent Ignacio Ruiz described the Climate and Culture Survey which got 4,000 responses (from parents, staff, community members, and students). Data will be used to inform decision making in the district. There is a big disconnect between opinions of teachers and students/parents about the instructional school climate. Teachers are satisfied with how students are updated about their progress and how lessons are connected to life outside of school. Students and parents are much less satisfied. Many recommendations for change came out of the survey.

Meanwhile, a new contract for Superintendent Ruiz of \$220,000/fiscal year, plus other benefits was approved unanimously.

Deputy Superintendent Gabe Jacquez reported on weapons detection and confiscation. The infractions were greatly reduced in 2023-2024 than in 2022-2023. More counselors and social workers are needed in the schools. The District will continue to address the issue. The Superintendent talked about the Round Table meetings being held among city groups, such as the Chambers of Commerce.

Jacquez also reported on the transportation situation. Bus drivers are receiving a raise in salary. There are 103 routes planned for 2024-2025 school year. All buses are now heated and air conditioned. In the past there were problems with late buses and timing reports were not always accurate. Routes will continue to be analyzed. The Board needs analysis of costs associated with bus drivers becoming full employees of the district. Allocations for transportation have decreased for this coming year. The motion to accept the transportation allocation for 2024-2024 passed unanimously.

Jacquez also discussed the School Resource Officers (SRO) plan for the 2024-2025 year, which includes the Las Cruces Police Department, City of Las Cruces, and the Town of Mesilla. SROs are assigned to schools with communication among principals. Monthly activity reports are given to the principals. SRO contract agreements were approved by the Board.

Policy AD School District Vision, Mission, and Value Statement, passed unanimously, while the updates for Policy GBGBA Employee Assault and/or Battery had its first reading.

- Approved: Declaration of extreme drought conditions within Las Cruces and restriction on use of fireworks for 30 days (effective through July 6).
- Not approved: A resolution to reverse the Planning and Zoning Commission's approval of a replat in the area of Madrid and Triviz (formerly a flood zone).



Las Cruces City Council Work Session

The proposed master plan for the Las Cruces Public Libraries includes over the first five years: Increased funding of staff, establishment of a library foundation, additional children's and Spanish books, design of a prototype branch library, loan of laptops for in-library use to expand computer services, increased library programs and outreach, and opening a Friends' bookstore in the library. The session was attended by numerous members of the Friends of the Branigan Memorial Library and other supporters.

John Harris, CEO of Memorial Medical Center for about 10 years, began his presentation expressing concern about a recent story on NBC News which he described as containing inaccuracies including allegations that MMC denies care. He said that the hospital has been very progressive in providing payment options and that he has been working with Jamie Michael of the NM Health Department concerning cancer care. He indicated that MMC provides \$54 million in charity care, uninsured discounts, and uncompensated care. Several councilors expressed disappointment that there was not more substance to the presentation, asked about the availability of quality measures, and asked that more data be presented at a public meeting. Mr. Harris stated emphatically that he, not Apollo (the private equity firm that owns MMC), runs the hospital.

El Paso Electric gave a short report on damages, outages, and repairs because of five storms cells that occurred over the weekend of June 29-June 30. Most outages had been restored but several power poles were snapped and will be replaced soon.

Resolutions, council bills and outcomes:

- #25-001 and #25-002: These resolutions to accept grant awards passed.
- #25-003: This was a resolution to reverse a previous denial for development at 725 McClure Road. The resolution passed.
- #24-028: An amendment to ordinance 2698 regarding gross receipts tax passed.
- #24-029: This ordinance for a zone change at 2605 Bataan Memorial West was postponed until July 15.

Las Cruces City Council • Work Session

Three topics were covered. Under Economic Development Updates there were presentations from Film Las Cruces and the Farmers and Crafts Market. This was followed by discussion of a proposed policy relating to industrial revenue bonds, a tool which the city has not been using in the Las Cruces Innovation and Industrial Park but which the county has used for the Pedrena housing project. It doesn't involve bonds but provides a tax exemption to finance land, buildings, equipment, and infrastructure. The final topic was revisions to the accountability in government ordinance. The proposal adds definitions of terms such as waste, fraud, and abuse (consistent with state and federal definitions) and provides improved independence for the Office of Inspector General. It also would remove some criminal penalties in an effort to promote truthfulness and cooperation by employees. There was an interesting discussion by councilors of chain of command and the role of the Inspector General with respect to volunteers on city boards and commissions.
