Happy June Everyone!

Election day is just about here and I would guess that many of you have already voted. Once the election is over, and after the League takes a minivacay in July (no meetings), we'll resume our work to get people ready to vote in the General Election. A critical election, for sure!

For now, let's celebrate what the coming weeks will bring us: Flag Day (June 14th), Juneteenth (June 19th, <u>see page 9</u>), and Independence Day (July 4th). Unfortunately, I find it ironic that as we celebrate these special occasions, we also wrestle with the question of whether our nation's Supreme Court is honoring the tenets for America's third branch of government. Is each Justice maintaining her/his commitment to being fair, unbiased, apolitical, and ethical when determining the nation's most complicated court cases?

As you know, in one recent example, a Justice is now facing criticism for having a US flag flown upside-down at his home, and a second flag at another home; both are seemingly connected with the January 6th insurrection. Even if it was a family member who may

have posted the flags, we have to ask ourselves whether this Justice should be allowed to rule in cases that relate to "#Stop the Steal." Can he be unbiased? Should he recuse himself? What do you think?

In today's political climate, what *are* the standards for our Justices and why does their <u>Code of Conduct</u> have no teeth? Is this appropriate for the highest court in the land? Even though they are selected by the President, we *do* vote for many levels of the judiciary. And, we *do* vote for a President who determines which Justices will serve on the bench. I suppose that has to suffice, for now.

Voter Registration Results for DAC High School Students

As a Content Specialist for Middle School ELA for the Las Cruces Public Schools, Josie Miller and her co-workers organize voter registration events in the high schools on election years. This is a very important election year for our country because more voters turn out for Presidential elections. The Las Cruces Public Schools partnered with the Doña Ana County Clerk's office, Sign-Up Genius for voter registration agents operated by Stewart Oberman, and the League of Women Voters of Southern New Mexico, to provide voter registration agents (VRAs) to register 18-year- old students or those who will turn 18 by the next election in 2024.

The VRA's worked at the following schools in Doña Ana County over the last several weeks and were able to register 634 students!

Guest Column Hopes to Spark Public Participation

In Las Cruces, like much of the United States, we are experiencing a housing crisis. Interest rates remain high (7% in April), and Las Cruces home values continue to rise after increasing 23% between 2019 and 2022. Only a small number of new homes are starter homes. Since 2017, rent in New Mexico has increased by 70%, leap-frogging over a 15% growth in wages. More than half of Las Cruces area renters are rent-burdened paying more than 30% of their income on rent.

We must address our housing shortage from every angle, ranging from incentives to regulatory reform to help renters and homeowners at every income level and stage of life. Realize Las Cruces, which revises the City's land development code, is a longterm policy strategy designed to address these problems.

Realize Las Cruces will unlock restrictions on incremental development of attainable housing or "missing middle" housing in the City of Las Cruces. Specifically, the goal of the City's proposed design standards and

zoning reforms is to give property owners, home-

interest as we get closer to November.

builders, and developers more freedom to build missing-middle housing and mixed-use, walkable neighborhoods, including Accessory Dwelling Units, townhomes, duplexes, small apartment buildings, clustered housing and more.

All of us stand to benefit. Consider a young professional who just graduated from NMSU beginning their entrylevel career. Given the shortage of affordable apartments and high-interest rates, they will struggle to find a home within their reach and may consider moving to another city. Consider newlyweds who are looking to start a family and buy a small, economical starter-home. What if they could stop renting and start building home equity? Consider seniors who want to downsize but remain in the same neighborhood. As of today, that may not be possible. But with Realize Las Cruces, residents will be able to rent, buy or build housing, while expanding property values and city revenues.

Zoning transformations like Realize Las Cruces are proven tools to build enduring prosperity in Las Cruces. Communities that enacted similar reforms saw increased housing stability, property values climb, and available housing stock grow. For example: after implementing a similar policy, Tysons, Virginia saw an increase in available homes by 23% (U.S. avg: 3%), and an increase in rent of just 4% (U.S. avg: 31%). Realize Las Cruces incorporates best practices from across the country to address housing shortages through long-term policy change.

Las Cruces' success depends on us addressing housing at every level, with investments in infrastructure, publicprivate partnerships, and policy change. Realize Las Cruces will build prosperity in our community in innovative ways. Please speak up in support of Realize Las Cruces at the upcoming work sessions and City Council meetings.

LAS CRUCES PUBLIC SCHOOLS BOARD OF EDUCATION • Regular Meeting

Members in Attendance: Teresa Tenorio, Bob Wofford, Ed Frank, and Pam Cort; and Supt. Ignacio Ruiz.

LIBRARY CHALLENGES

Two members of the audience spoke during public input with concerns about books in LCPS libraries. One person blasted the book "Push" which has been challenged in other parts of the country. The audience member said it's available in a local high school, and he questioned the book's educational value. He said students should not be exposed to the content. *{The book also became the movie "Precious" and centers on an African American girl who is sexually assaulted by her father, and she ends up with two children.*] Another parent said there is also pornographic material in school libraries, and he said the School Board should "correct things" and should be listening to parents as to what type of library books should be allowed, as he doesn't want children exposed "to this smut." He criticized the Board saying a recent Board policy revision "is basically replacing a flawed process with another flawed process."

DISTRICT BUDGET

The Board also approved 4-0 (member Patrick Nolan was absent) the district's largest operational budget ever, totaling more than \$625.8 million for the 2024/25 fiscal year. The budget contains a 3% increase for all school personnel. Finance officials said the budget went through three town hall meetings and included items recommended through a community survey. The top public priorities were campus safety, facilities, and instructional resources. All three of those were included in the proposed budget:

- o \$2.1M for school safety, including fences, playground improvements, intercom systems, and more;
- \$42.7M for facilities, including a new Columbia Elementary, elementary multipurpose rooms, heating/cooling, and roofs;
- o \$18.5M for new furniture for four elementary schools;
- \$7.65M for instructional resources including a STEM outreach program from NMSU, software, and materials.

It was also noted that previous federal COVID funding is no longer available and that district personnel will be facing increases of 15.5%, 5% and 3% for medical, dental and vision coverages, respectively.

Finally, to address survey questions from the community, the audience was shown how class loads are addressed (meaning the number of teachers assigned to the number of students) in a budget process. Figures for classrooms (except for bilingual) are based on this state formula:

- 1. **Kindergarten** cannot exceed 20 students (classrooms with 15-20 students are entitled to an Education Assistant (EA);
- 2. **Grades 1-3** on the average cannot exceed 22 students (1st grade classrooms with 21 or more are entitled to an EA);
- 3. Grades 4-6 on the average cannot exceed 24 students;
- 4. **Grades 7-12** cannot exceed 160 students daily (English courses grades 7-8 not to exceed 27 students max; English courses grades 9-12 not to exceed 30 students max).



LAS CRUCES CITY COUNCIL • Regular Session

The audience was completely filled, mostly with Palestinian supporters and members of the Jewish community. The full house was due to the final agenda item, a resolution that called for a cease fire in Gaza.

Before public input, Mayor Enriquez asked for a motion to remove the cease fire resolution from the day's agenda. This motion passed. Most of the Palestinian supporters stormed out yelling. Over two hours was spent hearing mostly from citizens against the cease fire resolution, though it was no longer under consideration.

Resolutions:

- Resolution passed to appoint James Derossit as municipal judge II.
- Resolution passed on rehabilitation of residence at 1001 Colorado Avenue.

• Two resolutions passed dealing with city finances: (1) adoption of funding to non-profit organizations to provide health-related public service and (2) authorization of \$1,100,000 from the Telshor Fund for the police department's "real time crime center."

LAS CRUCES CITY COUNCIL • Work Session

The first work session was held jointly with the Doña Ana County Commission to receive a status report on the opiod settlement funds. Over a 17-year period, \$9.9 million will be allocated to the City of Las Cruces, \$14.5 million to Doña Ana County, and \$711,000 to Sunland Park. So far, Las Cruces has received about \$3.5 million. Shara Thorpe is the DAC Opiod Settlement Coordinator and there is an advisory council working to determine how the funds should be spent. Allowable uses focus on treatment, prevention, first responder training and related activities. Currently a needs assessment by NMSU Crimson Research is under way, including compiling administrative data, and meeting with key informants such as first responders and those with lived experience related to opiods.

The second work session addressed the LIGHT (Lessen the Impact of Grief, Harm, and Trauma) program which was launched about a year ago and which includes social workers among the first responders. Average time on task per call has been two hours and the cost per call is lower than for general emergency response calls. Providers were described as patient-focused, and they do not hurry through their contacts.

The second topic of this session was "revenue options to create a sustainable capital improvement fund." Potential sources of funding for capital infrastructure include capital outlay (which is not intended to provide full funding for projects), GO bonds, property taxes and gross receipts taxes. The city has recently conducted a community opinion survey and found a willingness among registered voters to support additional gross receipts taxes for projects in the area of public safety, parks and recreation, streets, and other quality of life issues such as libraries and museums. Action may be taken on how to proceed at a Council meeting in July.



LAS CRUCES CITY COUNCIL • Regular Meeting

May 20, 2024 Observer: Kathy Brook

The main items on the agenda were approval of the budget and the capital improvement program for 2024-2025. The proposed budget was approved with amendments to provide \$200,000 for support services for public safety employees and \$300,000 for the Community of Hope Mano y Mano program. Funding for both items will come from the Telshor fund.

There was considerable discussion about the use of the Telshor fund which has a current market value of about \$42 million. The city has been using the interest earnings from the fund but with this budget will be reducing the fund by about \$28 million (mostly for capital expenditures including affordable housing). Discussion included questions about what the city would do when it no longer has a flow of interest from the Telshor fund. One alternative source of funds is grants, an area where the city is now more active.

The Exvangelicals: Loving, Living, and Leaving the White Evangelical Church

Growing up in a deeply evangelical family in the Midwest in the '80s and '90s, Sarah McCammon was strictly taught to fear God, obey him, and not question the faith. McCammon was a rule-follower and—most of the time—a true believer. But through it all, she was increasingly plagued by fears and deep questions as the belief system she'd been carefully taught clashed with her expanding understanding of the outside world. After spending her early adult life striving to make sense of an unraveling worldview, by her 30s, she found herself face-to-face with it once again as she covered the Trump campaign for NPR, where she witnessed first-hand the power and influence that evangelical Christian beliefs held on the political right. Sarah is among a rising generation of the children of evangelicalism who are growing up and fleeing the fold, who are thinking for themselves and deconstructing what feel like the "alternative facts" of their childhood.

The May 18, 2024 guest speaker was Rosenda Chavez-Lara. She is one of the two people campaigning to be the Democratic candidate for the District III Municipal (city) Judge. Ms. Chavez-Lara talked about her personal background, professional legal experience, and plans for change, if elected in November. Neither Ms. Chavez-Lara nor her opponent are on the Primary Election ballot. Instead, the Democratic candidate will be selected by the Central Committee of the Democratic Party of Doña Ana.

State Senator Jeff Steinborn asked for support for a proposed Mimbres Peak National Monument designation, something either the U.S. President or Congress can do. This national monument would encompass federally owned land south and north of Deming and include three mountain ranges. The NAACP members passed a resolution to support the creation of this national monument.
