

Make Your Voice Heard Beyond the Ballot Box

With the conclusion of election season, many Leagues, including LWVNM, are turning their attention to state legislative sessions. Please join LWVSNM and co-hosts AAUW and NAACP for our annual legislative conversation on Saturday, Dec. 7, beginning at 11:30 a.m. at the Doña Community College Workforce Center (2345 Nevada Ave.) where we will find out the priorities of legislators in attendance and share our own concerns. Also, all League members in New Mexico are welcome to join the state League Action Committee, whose first Zoom meeting is scheduled for Monday, December 9, at 6 p.m. The purposes of the meeting are to decide on top legislative priorities for the 2025 season and to pick a meeting day and time for weekly Action meetings during the session. Remember that advocacy by LWVNM depends on having a state or national League position as a basis for that advocacy.

By participating in the Action meetings, you can stay updated on what is happening in the legislature and, in some cases, be authorized to speak on behalf of the League. To receive Action Alerts and/or join the Action Committee, click here.

LWVNM has responsibility for ensuring that the League speaks with one voice to the legislature concerning state issues. So, only those who are authorized by LWVNM may speak in the name of the League. League members, of course, are encouraged to take advantage of opportunities to speak as individuals to their own legislators or in-person or online to legislative committees.

There are a number of important issues that are likely to come before the legislature during the 60-day session that begins January 21, 2025. These include proposals for an independent commission concerning legislative salaries; affordable housing; health care topics ranging from consolidation of health care providers, addressing shortages of health care personnel, and expansion of Medicaid; budget issues such as increases in the royalty rate for oil and gas; education; immigration impacts on NM; and protection of NM waterways.

Big Changes Are Coming for Membership Dues and Renewals

Starting on February 1, 2025, the national League of Women Voters organization, which encompasses all local Leagues, is shifting to a new membership process that will change how you pay dues and renew your membership. These changes will help to modernize the LWV and attract new members. While several questions will certainly come up during the next few months, our Board members are attending training sessions that will help us understand how the new "ChapterSpot" league membership platform will work.

The new membership process will include an online dues-paying method, but we are assured by national that local hard-copy checks can still be given to our local Treasurer. In the meantime, you're encouraged to read about ChapterSpot on the national website; and a Q&A is also provided. https://www.lwv.org/league-management/membership/lwv-new-membership-

Rest assured, we will continue to notify members with additional information. So, as we learn the new system, we wanted all members to have this sneak preview:

DUES

system-faqs#Types

- Dues amounts will be "pay what you can afford." The percentage that local leagues will receive (including SNM) is intended to be greater with a lower percentage sent to national. This is intended to benefit local leagues. The national League has recommended dues be \$75 a year, with a minimum amount of \$20 a year.
- There will no longer be a dues level for students.
 (Currently their dues are free.) However, a second household member will remain as an option.

Still to be determined:

- The local Board will discuss the actual yearly amount that SNM will recommend for its members; the minimum, however, will be \$20.
- The Board will also have to determine whether the local budget can cover the cost for students (in full or partially), or perhaps they could be asked to pay the minimum of \$20.

- The Board will determine what will be as recommended dues for second household members. (Currently they pay half.)
- Lifetime members (those who have been members for 50+ years), including several from our League, will continue to be exempt from paying dues.

RENEWAL

- Membership renewals will occur throughout the year depending on when you first joined. Since SNM begins the renewal period on May 1 this will continue to be your annual payment schedule. But for new members who join, for example, on Nov. 15, they will be notified through ChapterSpot to renew each Nov. 15.
- You'll renew your membership on the national League website.
 - Still to be determined: For members who prefer to send checks to our treasurer, our Board will discuss how to process the local payment and/or whether a board member can assist those who need online help.

MISC. INFORMATION

- When first renewing online, there will be a standard process of filling out your name, address, etc. However, in order to join on the national ChapterSpot site, you must use your own, personal email account. Plus, LWV has decided that other confidential information that must be captured will include your age. However, that data will not be shared.
 - Still to be determined: The local Board will discuss how to assist members who do not have an email account.

Finally, if you have any thoughts that you would like to share with the Board, please email any one of us. Or email lwvsnm@gmail.com. And for questions we cannot answer, we'll get the answer from national.

The State League's Search for a Treasurer


